Recruiting Programs

- Large law firms and other legal employers that can project hiring needs one to two years in advance recruit for their offices nationwide by participating in our annual *Fall Interview Program*, either through on-campus interviewing or collection of resumes. These recruiters hire 2L students for summer associate or intern positions and 3L students for entry-level associate/attorney positions.

Programming & Resources

- Career development programs on a wide variety of topics are presented throughout the academic year. For the convenience of the student body, programs are offered during time periods when no classes are scheduled as well videotaped for those students unable to attend.
- Our *Alumnae/i Advisor Network* is an on-line searchable database of graduates throughout the country who have agreed to share information about the legal marketplace, particular practice areas, and job search strategies with students and other alums. More than 400 alumni are currently in this database.
- More than 300 resource directories and reference books are available in our office's resource library. A separate set of these resources is also housed in the law school's main library so students may check them out for use at home. Additionally, we maintain extensive files on hundreds of individual legal and law related employers. Many additional resources are available through our website.

Job Listings

- Part- and full-time law clerking positions, attorney opportunities, and non-law professional openings are made available through our web-based job listing system, which is updated daily. More than 1200 job listings are posted through our office each year. Approximately half of these listings refer to clerking positions appropriate to students, while the other half are for graduating 3Ls and alumnae/i.
